Abstract: This collection, an amalgamation of sources and materials spanning nearly two centuries, consists largely of court dockets, deeds, articles of agreement, account information, and correspondence related to Charles Bartles, his law practice, and his family. One principal attraction of this collection is the group of court docket books within it; these dockets are highly valuable as they supplement the official record of cases from the Hunterdon County Court of Common Pleas for the first half of the nineteenth century. Other items of note include documents discussing the treatment and sale of slaves in the area, the construction of the Flemington Rail Road, and the Civil War as it related to Hunterdon County.

BIOGRAPHICAL NOTES:

Charles Bartles was born in New Germantown, New Jersey on March 18, 1801. After graduating from Union College in Schenectady, New York, he began his prosperous career as a lawyer as a student at the office of Nathaniel Saxton in 1822. Bartles married Eliza Hart of Flemington in 1833 and had four children, Mary, William H., Charles Jr., and George. From his second marriage to Eliza E. Randall in 1846, following his first wife's death the previous year, he had two more children, Joseph and Margaret. Bartles was successful in real estate operations, integral to the construction of the Flemington Rail Road as well as its first president, and president of the Hunterdon County Bank beginning in 1858. He died on June 19, 1883.

SCOPE AND CONTENT:

This collection is divided into 12 sub-collections, or series.

1. John Bryan Papers.

Dating from 1778 to 1822, this prominent lawyer's manuscripts consist largely of deeds, articles of agreement, maps, account information, and correspondence. Of particular interest are materials regarding an eighteenth-century divorce, the sale of slaves in the early 1800s, a blacksmith business partnership including "Negro" work, the running of a distillery, and details regarding the lime industry.

2. Charles Bartles Papers.

The highlights of this series of deeds, account information, surveys, and correspondence center on several State of New Jersey writs, an 1836 articles of agreement document between Jacob Rockafellow and the Neshanic Mining Company, and two letters from the Civil War era, one in which Charles Bartles agrees to pay for uniforms and India rubber blankets for Flemington volunteers, and the other in which five volunteers fighting in the war confront him about his promise to care for their families.

3. Court Dockets.

These four historically valuable court dockets from the early to mid-nineteenth century are believed to be missing from the County's collection.

4. Flemington Rail Road Collection

The documents and dividend receipt books for this significant series date from 1853 to 1881 and encompass work proposals, articles of agreement, blank mortgage bond certificates, financial information, an application to the New Jersey Supreme Court regarding construction, and reports to the Legislature of the State of New Jersey.

5. Dr. William H. Bartles Papers

Highlights from these materials related to Dr. William Hart Bartles, Charles's first son with his first wife, Eliza Hart, include a detailed 1905 letter from his nephew, F.R. Bartles (whose father was Charles Bartles, Jr.), describing his work on the Panama Canal and overall conditions there, as well as lecture tickets for Jefferson Medical College of Philadelphia dating from 1862 to 1864. Dr. Bartles was born in Flemington and worked as a lawyer for one year before changing his profession. He was a staff member of the Pennsylvania Hospital for the Insane for several years and also practiced medicine privately in Philadelphia.

6. D. Bartles, Mrs. George Bartles & Mrs. Eliza Bartles Materials

Aside from two receipts, this series consists of an undated plane trigonometry/surveying notebook belonging to D. Bartles.

7. William W. Hawke and Elizabeth Bartles Hawke Papers

This series collects materials pertaining to Flemington dentist and prominent citizen William Wetherill Hawke and his wife Elizabeth Bartles Hawke, who was Joseph Bartles's daughter and the niece of William Hart Bartles. Of special interest are several documents dating from 1917 discussing World War I service. Dr. Hawke was born on September 11, 1864 in Blawenburg, New Jersey, graduated from the University of Pennsylvania's dental school, and married Elizabeth Bartles in 1897. He was very active in the Flemington Presbyterian Church, Hunterdon County Y.M.C.A, and Hunterdon County Historical Society, and he died on April 4, 1940.

8. Miscellaneous Military Documents

Ranging in date from 1814 to 1861, these materials include information about the Fifth Troop of the Hunterdon Squadron, as well as Company H of the New Jersey Brigade, Third Regiment Hunterdon Volunteers.

9. Miscellaneous Manuscript Ledgers

This series collects assorted handwritten account information chiefly from the 19th century.

10. Non-associated Materials

These miscellaneous materials range from rules for the collection and rates of toll on the Lehigh Canal to a pamphlet from the Clinton chapter of the Royal Arch Masons and a 1917 Flemington Fair program.

11. Newspapers

This collection is comprised of three mid-19th-century *Hunterdon Gazettes*, one 1902 *Philadelphia Times*, and a 1916 *State Republican News*, as well as of special note, a *Panama Journal* from 1905 printed in Spanish and English.

12. Photographs

These undated, black-and-white prints include a hand-colored Sunderlin Studio portrait of an unidentified Caucasian woman, a group portrait, and two views of the Flemington landscape from Mullin Hill.
