**Scope & Content / Abstract:**

Abstract: This collection is composed of petitions to the Freeholders and Road Commissioners of Hunterdon County, along with other correspondence, pertaining to the construction and maintenance of roadways throughout the county. The petitions contain the signatures of many citizens from affected areas, and are an interesting source of information about the development of county roads and their use.

Scope and Content: The collection is organized mostly according to the geographic areas in question. The first folder contain documents for the Flemington Junction to Whitehouse roadway, and the next contains correspondence regarding roadways in Raritan Township.

There is also a folder about building a road from the village of Flemington to Wolff's Mill, and another folder concerning a road from Stover's Mill to Klinesville.

Also included in the collection is a folder of road related records, including pamphlets of state roadway laws, copies of road legislation, and state aid to road building. Lastly, there is a folder of records that cannot be related to any identifiable road.
