New Jersey's Sourland Mountain Topic of Annual Meeting

2 p.m. - 14 April 2002 - Flemington Womens Club

Historiographer T. James Luce, Jr., author of *New Jersey's Sourland Mountain*, published late last year will be the guest speaker at the Society's Annual Meeting on Sunday, 14 April, at 2 p.m. in the Flemington Womens Club. He came to the Sourland Mountain in 1963, and has resided in a house built on the foundation of the O'Neill summer house where future playwright Eugene and painters George Bellows and Edward Keefe spent the winter of 1909. Mr. Luce's interest in the area grew after he came to the house and he became a founding member of the Sourland Planning Council which sponsored his book. He has retired from Princeton University where he spent nearly forty years, a classics professor.

The Keith Line, historically dividing East and West Jersey, runs through the Sourland Mountain, establishing the western boundary of Hunterdon and Mercer Counties and the eastern boundary of Somerset County. Sourland Mountain is roughly seventeen miles long and four miles wide, running northwest from the Delaware River (Lambertville) to a point just beyond Neshanic. It is fifty miles equidistant from Philadelphia and

New York and parallels a section of the metropolitan corridor stretching from Boston to Washington, DC and yet, despite suburban sprawl creeping along its flanks, which in recent years has threatened to turn into a gallop, it still retains much of its unspoiled character. Although the Mountain is the product of a single geological process, it is nearly pinched in two. A narrow neck of high ground near Rocktown preserves the connection between the two sections.

Join the Society for a brief Annual Meeting, Mr. Luce's presentation, and refreshments. As always, meetings are open to the public.

Emigrants to Northumberland County, Pennsylvania

"Went west" is sometimes the frustrating last entry in a genealogical study. Then it's where to go from there? Well, "old" Northumberland County, Pennsylvania, along the Susquehanna River, is one place to look. The county, as originally laid out in 1772, included about thirty of the present counties, including Columbia and Montour, Snyder, Union, Luzerne, Centre, and Lycoming. Well before 1933 genealogist-historian Heber G[ossler]. Gearhart of Sunbury [genealogically we might say the Hiram E. Deats of his area] in Northumberland County began studying and acquiring information on emigrants to his area. He and Mr. Deats, HCHS librarian, corresponded about the families who came from Hunterdon County.

In early 1933, Mr. Gearhart sent along to Mr. Deats his list of emigrants, giving the date of emigration "before 1790" or "after 1790," This distinction he based on the 1790 census. His ancestor, Captain Jacob Gearhart, of course, went there from Hunterdon. He collected much the same information for "old" Northumberland families that Deats did for Hunterdon — family information, Bibles, land records, cemetery inscriptions, etc. At his death his extensive collection was donated to the Historical Society of Pennsylvania and is available there on microfilm. In 1985 I reviewed the collection, with the foregoing list in hand, and identified numerous additional surnames I recognized as occurring in Hunterdon records. Therefore, do not assume if your ancestor's name is not cited, there will be no information in Mr. Gearhart's collection about the family.





Silvia was the subject of a pamphlet, *The Slave Who Whipped Her Mistress*, authored by Dr. Cornelius W. Larison of Ringoes, in 1883. He first interviewed her on a 20 degree Saturday in January 1883 at Cedar Summit in the Sourland Mountain and his second interview was in December the same year. The above photograph of Silvia and her daughter, Elizabeth Alexander, was taken by a Flemington photographer.

She was purported to have been born in March 1768, therefore putting her age at 114 when Dr. Larison first interviewed her. While this may be factual, she gave her age as 45 to the census enumerator in 1850, thus placing her birth year at 1804/5. Her father, Cuffee Baird, was a fifer at the Battle of Princeton, and her mother was Dorcas Compton.

Silvia related in a subsequent newspaper interview that "the folks up around here are the worst set that ever lived; they lie, steal, cheat, and murder, too . . . Nevertheless, there are many persons living on the mountain who are upright, honest citizens."

An 1804 law provided for the gradual abolition of slavery in New Jersey whereby children of slaves born before 1804 were to have their freedom, males at age 25, and females at age 21. Silvia would then, if born 1804/5, automatically been freed when she turned 21.
