Scope & Content / Abstract:

This collection is a group of unrelated items that was donated to the Hunterdon County Hunterdon Society by D. Hanover. The records donated are clearly material that was collected by Hiram E. Deats, and that the donor somehow obtained the material in the disposition of the Deats estate or perhaps earlier from Mr. Deats himself. A number of items are personal records and many more are items of county or state history, some bearing Deat's name or the stamp of the Hunterdon County Historical Society. The collection is important because it repatriates documents to the Historical Society and provides documentary evidence concerning several county residents and organizations, including Mr. Deats.
