Scope & Content / Abstract:

Abstract: This collection is comprised of photocopies of files documenting the service record of Revolutionary War soldiers. Most of the documents were obtained from the US National Archives. The files were assembled by the Federal Government for the purposes of providing veteran's pensions. Many, but not all, of the soldiers documented are from Hunterdon County.

The collection is arranged simply in alphabetical order. Each folder has items such as certificate of pension, oaths certifying service, and descriptions of said service.
