Scope & Content / Abstract:

Scope/Content: The collection is arranged as follows:

Folders 1-6 contain account books and papers relating to Herman Hageman and the Hageman Farm on Hillcrest Road, Readington Township. Folders 7-27 relate to the Pleasant Run area, including an account book of John K. Thompson, and photos and other ephemera from the Pleasant Run School reunions of 1937 and 1938. Folders 28-53 consist of various photographs, including four ferrotypes and two daguerrotypes. The remaining 40 folders consist of photographs from a photo album belonging to Herman Hageman.

Abstract: The collection relates to families of the Pleasant Run section of Readington Township. It consists of 93 folders containing deeds, 5 account books and 83 photographs of several generations of the Hageman family and other allied families of Pleasant Run, in Readington Township, Hunterdon County, NJ ca. 1850 - ca. 1910. Anyone interested in that area of Readington Township, the Pleasant Run School, the Hageman, Thompson or Cole families would find this collection useful.

Name of Creator: Alice L. Hageman

Administrative / Biographical history: The Hageman Family had lived in Readington Township since the late 18th or early 19th century. Herman and Ester Hageman lived on Hillcrest Road in the Pleasant Run section of Readington Township and had 6 children, two of which, Andrew and Herman, became ministers of the Reformed Church, Herman, born in 1858, married Ritie Amerman in 1883, Herman served as paster of the Claverack NY Reformed Church for 28 years and died in 1950.
