**Abstract:** The Large Papers are comprised of 9 document cases. Three of the boxes are primarily concerned with personal, family, and business correspondence. Five of the boxes contain records pertaining to specific cases in which one or all of the Larges were principally involved as attorneys. The last box contains records from the Large and other associated families that are more genealogical in nature. The importance of this collection arises from: 1.) The personal, professional, and business records of an important mid-nineteenth century New Jersey politician and attorney; 2.) Information concerning the case works of attorneys in late nineteenth and early twentieth century Hunterdon County; and 3.) Social and genealogical information concerning the Large and other Hunterdon County families.

## **BIOGRAPHICAL NOTES:**

John K. Large (1810-1879) was a successful businessman and government official from Hunterdon County, NJ. He primarily lived in White House, NJ, and during his lifetime acted as an appointed official in various capacities, including serving as a freeholder of the county and as the County Collector in 1855.

George H. Large (1850-1939), the son of John K., was a prominent attorney and elected official. Born in White House, he lived most of his adult life in Flemington, NJ. After receiving an education from Rutgers College, he studied for and entered the Hunterdon County bar in 1875. After ten years of successful practice, eventually achieving the post of Master in Chancery, he was elected as a State Senator in 1886. In 1888 he served as the President of the NJ Senate and stayed in office for years, occasionally serving as Acting Governor of the state when need required.

Interestingly, despite his highly successful career as a lawyer and Senator, the achievement he was most proud of in later years was athletic. While at Rutgers, in 1869,

he was a member of the Rutgers team that played what is generally considered to be the first intercollegiate football game when Rutgers defeated Princeton 6-4.

The law practice of Large and Large was formed later in his life, when he took in his sons, George K. and Edwin K., both successful attorneys, as his associates. George K. finished his career later as a respected Hunterdon County Judge, while Edwin K. eventually moved to Atlanta, Georgia and became a United States Postmaster.
