Administrative / Biographical history: The New Hope Delaware Bridge Company, Incorporated in 1812, was chartered to construct and operate a bridge over the Delaware River, and make a profit for the shareholders. The company ran into financial difficulty in 1826. In order to restore confidence in the company and to attract further investment, the company sought to establish banking privileges. To do this, it sought legal opinion to justify the action and to further increase confidence in the Company Board.
