NOTES ON THE CAPNER PAPERS

The Capner Papers were processed in the Summer of 1980 according to the principles laid down by the Society of American Archivists, and the Association for State and Local History.

There are two main principles: (1) Provenance, (2) Registry.

Provenance means the history of the manuscript or manuscripts. That is, where and by whom did they originate. Information as to the successive transfers of ownership and custody. What changes were made. What is, or may be, missing. Etc., etc.

Registry means that manuscripts should remain in their original organizational pattern or structure and in their original filing arrangement in order to preserve all relationships. It is the basic archival principle.

This principle explains why there are, to the non-expert, certain anomalies, such as the lack of strict chronology, for example. Some series of documents may go back and forth. 1820 might be followed by 1815, and 1815 by 1820 again, and that by 1812, and back to 1835, or what ever. Nevertheless, according to the Registry principle, the original order must be followed. Sometimes this principle is called (partly in jest) as The Sanctity of the Original Order."

Provenance of the Capner Papers. They were acquired by Hiram E. Deats from the attic of the Capner home in 1891. Since then the material in the first 664 folders has been used or sorted by at least 14 people. Thus the original order is not known.

Folders 1 to 218 were sorted by Dr Hubert G. Schmidt about 20 or 25 years ago. The marks, repairs, and comments are his. In the 1980 processing, clips, pins, rubber bands, string, etc., were removed, and the material was placed in new, acid-free folders. Some of the items have been torn, some are missing. The cause or reason is not known. The typescripts were made by Mrs Frederick Powell, and there is evidence she had at least 3 helpers.

Folders 219 to 321 were partially sorted, probably by Dr Schmidt. Again, the original order is not known, so they were, like the rest of the collection, arranged as found in 1980.

Folders 322 to 664 were partially sorted by Dr Schmidt and B.A. Sorby. The same disposition was made as the above group of folders.

In contrast, the balance of the material (beginning with folder 665) was as found by Mr Deats in 1891. It is almost certain that the present 1980 order is that of those who collected the material.

This portion of the papers, except folders 1132 to 1161, were in 2 wooden boxes, with evidence of being exposed to attic heat, water, insects, etc. Some of the items were not slvagable for use. They may be found in folders marked "Fragments" or "Illegible".

The material in folders 1132 to 1161 were in far better condition, and apparently separated at some time from the rest of the section. They consist principally of drawings. The box was marked "John Hall (Capner)" (But see below on "Names.")

The following notes apply to the collection as a whole, but especially to the latter section (folders 665 to the end.)

(Over, please)

Many of the folders have "Bundle" or "Sub-bundle"marked on them. Abundle is a group of documents that were in some way together - by being folder within each other, tied with string or tape, in envelopes, etc. Sub- bundles are groups of papers found within the larger bundles. All items are as found. No attempt was made to sort them chronologically, alphabetically, by subject matter, or any other artificial way. (See Registry, above.) Example: A folder _(or folders), may be marked "Bundle - Folders 100 to 110". Folder 104 might be marked "Sub-bundle - 100 to 104" That would mean that bundle had a number of loose items, but within it there were the items bundled into what is now in folders 100 to 104. Etc.,

If a bundle is more than 1 folder (as is usual), the number of items marked on the folder is that of that folder, not of the bundle as a whole.

Folders marked with the name on the front flap may not contain only that person"s documents - he or she might have papers of others for some reason. Example! Thoms Capner's personal papers are sometimes found in folders marked "Thomas Capner, Justice" (which, incidently means that that folder contains papers relating to his court cases.) And vice versa.

The color of the folders has no significance; it is variation of the manufacturing process.

The spellings are those found on the documents, which may, as researchers in the field are well aware, vary considerably. Watch for variations.

The Capner Papers presents some difficulties as to names. Many names were duplicated in the family. John, Joseph, Mary, Anne, Elizabeth, seem to be favorites. To further complicate matters, they often used nicknames such as Polly or Nancy for each other, and passed the nicknames to their daughters. You might have 3 Marys nicknamed Polly! Be cautius about "brother" and "Sister". It is often a term of endearment rather than the expression of a physical relationship. The family name was originally Capnerhurst, changed to Capner when they came to this country. John Capner changed his name to John Hall, his uncle's name. In these papers it will be found marked as "John Hall (Capner)". The papers and drawings in folders 1132 to 1161 were marked "John Hall (Capner) when found. They may be by either John Hall (both were civil engineers), or even by others - some are so marked.

In the Thomas Capner legal papers "scire facias" (often misspelled (sciere") means a "show cause order"; "trover and conversion" means "found and converted to his own use." "State. of Demand" is the abbreviation for "Statement of Demand."

Ms means manuscript; MSS means manuscripts. n.d. means no date, no i.d. or n.i.d. means there was no identification as to writer or source. + after the number of items column on the Inventory sheets means there is, or are, typescripts for those items in the folder.

There are many folders marked "Fragments". These folders are within the group where they were found. Some were found in the general miscellany and could not be traced to any document or group of documents. They will be found in Box 18, folders 1123 to 1131.
