The Hiram Deats Papers came to the Society in 1963 and included the papers of his son, Hiriam E. Deats. As noted in the Hiram E. Deats Papers, these (Hiram Deats), were in no special order, and it is assumed that the disarray was due to the carelessness of those who moved them.

The great bulk of the papers are business papers, and no attempt was made to separate business papers from personal papers. In fact, they should not have been. See next paragraph.

In accordance with established prinicples, the collection is arranged, as far as possible, "as found". This excludes and arbitrary chonological arrangement. The researcher, therefore has to be wary of dates. Many folders overlap or are out of sequence. When a bundle was found (and there were many here) it is keplas such. The folders are so marked. If the folder contains the entire bundle, it is marked simply "Bundle". If the amount of material makes it necessary to use more than one folder, the folder will be marked "Bundle - Folders 41 to 50", or whatever the correst numbers may be. The number marked "items" is the number of items in that folder, not the entire bundle. The same rules apply to folders marked "sub-bundle".

Check the dates on the items carefully. Poor handwriting may connect, for instance, the top of the 5 with the next digit, thus making it either 51 or 57.

Many of the items over-lap also in subject matter. Bills may have correspondence attached, or vice versa.

Boxes 16 and 17 contain accounts, memoranda, bank books, etc. These are small note book types, and it was thought better to keep them in boxes in order that they be not lost. They are filed as dated or marked, but the actual contents are not always as Deats marked them. The same is true of the wrapppers found around the several bundles of items in the folders. Many of them, contained insertions, which have been removed to box 18, folders 565 to 599. These are of great variety, and often were the sole means of identification or dating.

Some of Hiram E. Deats were found in this group of papers. They are in box 15, folders 546-558. Do not confuse Hiram Deats with his son, Hiram E. Deats, nor with Hiram E. Deats cousin, who signed himself Hiram Deats, Jr. See next page.


Hiram Deats began the manufacture of plows at Quakertown, N.J. in 1831, and added stoves to his business in 1841. In 1852 the stove business was thansferred to Stockton, N.J. The same year he built a machine shop at Pittstown. This same year he formed a partnership with John Pierson, but apparently ran into difficulties, and was re-formed in 1857, finally it was dissolved. Details might be in the papers themselves - no complete reading is possible in arranging and inventorying the collectons.

In 1852 he added a factory/foundry at Pittstown, and the entire business was transferred from Quakertown. In 1860 he began to manufacture reapers and mowers.

He formed a partnership with William Case in 1863, which, in 1866 grew into Deats, Case & Co., the partners then included Hiram Deats, Lemuel M. Deats, William J. Case, and Rutan Case. Later the firm became L.M. Deats Co.

There is also some indication he once had a partnership with Higgins. Some of the material here is printed, or written, "Deats and Higgins." Further examination of the material is suggested.

Hiram Deats was either the sole proprietor or the senior partner for fifty years, from 1831 to April 1, 1881.



NOTE: This is not a complete genealogy. Its purpose is to show the relationship among the people whose papers are contained in this collection.
