Title: The Rittenhouse/Fuhrmann Papers

Scope & Content / Abstract:

Scope and Content: This collection contains folders that feature legal papers (indentures, bonds, deeds, and marriage certificates) relating to Albert H. Rittenhouse and his family. In addition, there is an extensive genealogy report of the Rittenhouse family and its descendents. The collection also contains a small amount of correspondence, news clippings, ephemera, and appointments of notary public for Albert H. Rittenhouse. Also included are 8 photographs, presumably of the Rittenhouse family and its activities.

Abstract: This collection is comprised of papers relating to the Albert H. Rittenhouse family of Hunterdon County. The creator of this collection is John B. Fuhrmann. This collection includes legal papers of the Rittenhouse family, detailed genealogical summaries, and photographs. The collection would be of interest important to researchers of the Rittenhouse/Fuhrmann family or those interested in viewing indentures, bonds and deeds from the late 19th century through the early 20th century.

Name of Creator: John B. Fuhrmann
 Administrative / Biographical history: Albert H. Rittenhouse of Hunterdon County was born February 26, 1854 and died February 1, 1937. John B. Fuhrmann was a descendent of the Rittenhouse family. He was a family physician for more than 20 years. He was born in 1917 and died on January 4, 1993 at the age of 75. He was the son of the late Barclay and Alberta Rittenhouse Fuhrmann.
