Abstract: This collection consists of private letters received by Ms. Lille Staats. The collection spans from 1904-1909, when Ms. Staats resided in Ringoes, NJ, and at McKinley Hospital in Trenton, NJ. Most of the letters are from her mother, also named Lillie.
