Title: Ruth and Elizabeth Ent Collection

Scope & Content / Abstract:

Abstract: This collection contains personal papers and memoirs of Elizabeth and Ruth Ent, of Hunterdon County, NJ. Their High School days at Flemington High School are prominently featured, as well as subsequent class reunions. Also included are records from Ruth from her years as a volunteer with Christian Endeavor (a volunteer organization) and from her work at the Flemington. Another prominent feature of the collection includes three scrap books of the sisters' experiences, as well as an excellent group of photographs featuring the Ent family and reunions of the Flemington High School classes of 1928 and 1931. This collection would interest researchers of the Flemington High School, Christian Endeavor, class reunions, the FlemIngton Auction Market, and the Ent family.

Scope and Content: This collection contains memorabilia of Elizabeth Ent from her high school years, Class of 1928. It also features memorabilia from Ruth Ent from her Flemington High School Class of 1931. There are also records and photographs of Ruth from her work in the Flemington Egg Auction, and her volunteer work with Christian Endeavor.

Box 1 contains records memorabilia, and ephemera from Flemington High School, 1924-1931, and also subsequent Class Reunions. It also includes records, memorabilia, and ephemera from the volunteer group Christian Endeavor and the Flemington Auction Market.

Box 2 contains photographs. The photographs are principally of the Flemington High School Class of 1931 70th reunion in 2001; a reunion of Flemington Egg Auction employees in 1985; volunteer work at Christian Endeavor, and miscellaneous other photographs.

Box 3 contains scrapbooks: one by Elizabeth Ent concerning and her High School days, 1928-1931; one by Ruth Ent of her Class Reunions, 1951-2001); and another by Ruth Ent concerning her work at Christian Endeavor, n.d.

Name of Creator: Ruth and Elizabeth Ent

Administrative / Biographical history: Ruth E. Ent (1914-2006) was born in Stockton, NJ. She was the daughter of William and Rheba Crum Ent. She lived in Stockton and then Sergeantsville, and attended Flemington High School, graduating in the Class of 1931. Ruth was employed at the Flemington Egg Auction, and then for many years as the supervising clerk at the county Agricultural Extension Service, retiring in 1972. Ms. Ent was a member of the Old Rocks Church in West Amwell, and was very active with the New Jersey Christian Endeavor group and the Hunterdon County Sorptimists.

After retiring to Whiting, NJ, she also lived in New Hope, Pa. Ms. Ent passed away in 2006.
