Title: George Engeman Jr. Papers
Extent of the unit of description: 3 boxes; 1.5 linear feet

Scope & Content / Abstract:

George Engeman Jr. was a former Mayor of Flemington. This collection includes correspondence concerning his father, George Engeman, and his uncle, William Engeman. It also includes a series of printed material from his father's days as a Midshipman in the Navy, his own education at the Bordentown Military Institute, and a selection of his father's articles published in Baltimore, MD newspapers. Records date from approximately 1908 to 1936.

Scope and Content: his collection is comprised of materials donated to the Historical Society by George Engeman Jr. (1929-1991). The first part of the collection includes correspondence from the years 1908-1925. This correspondence is from the generation prior to George Jr, and mostly concerns the naval career and death of his uncle William Engeman, his father, George Engeman, Sr., and his grandmother, Frances H. Engeman.

The second part of the collection includes publications. Some are from the school days of William and George Sr., from the Naval Academy. Others are from the Bordentown Military Institute. There is also a series of The Baltimore Sun, from George Jr.'s youth in Baltimore, Md., in which articles from Gerge Sr. have been published.

This collection would interest any researcher in the history of the Engeman family, which was an important family in the social and political fabric of Hunterdon County in the 20th century.

Context:

Name of Creator: George Engeman Jr.
Administrative / Biographical history: George Engeman Jr. (1929-1991) was born in Baltimore in 1929, the son of George and Polly Engeman. His grandmother was Frances H. (Large) Engeman.

George Jr. returned to the Flemington area to live in 1972. Earlier in his life, he served with the US Navy during the Korean War. In his career, he had received a MS in languages and a Ph.D in Spanish literature, and he taught at several colleges including Franklin and Marshall and Oakland University in Michigan.

After returning to Hunterdon County, he served as a hearing officer on the NJ Parole Board, Chaired the Hunterdon County Planning Board, and served as a councilman and Mayor of Flemington. He also was very active in the Friends Meeting of Quakertown and with the Thomas Edison College in Trenton.
