

240 Years - A Church and Its Families

The Hunterdon County Historical Society's Spring Meeting is scheduled for Sunday June 25 at 2 p.m. at Larison's Corner Presbyterian Church. The Church is celebrating its 240th anniversary and our Society is pleased to join in their celebration. Mrs. John (Jane Bellis) Duffy will be the guest speaker and she will present a talk illustrated with slides featuring the history of the Church and its families – Rockefeller, Case, Bellis, Young, Wert, and others.

The Church was founded by German settlers in the Amwell Valley as the Calvinistical High Dutch congregation in 1749 under the Coetus of Philadelphia. In 1810 it joined

with the First Presbyterian Church of Amwell near Reaville and the present Church was erected in 1818. To honor our ancestors who were part of these congregations a short memorial service will be conducted in the adjoining cemetery at 1:30 p.m.

John D. Rockefeller funded the project to erect a wall around the cemetery and he erected a large monument to his ancestor, Johan Peter Rockefeller, one of the early members of the 1749 congregation.

Join Society members Sunday June 25 at the Larison's Corner Presbyterian Church on the Old York Road near Ringoes.

Marriages

Married by the Rev. H.W. Hunt Mr. Cornelius B. Sheats of Readington to Miss Deborah Little of Bethlehem the 26th October 1840.

By the same the 10th November 1840 Mr. Mansfield Hummer of Lebanon to Miss Amy Bonnell of Bethlehem.

Deaths

Electa Ann daughter of Doctor Needham of Perryville, aged seven months & 5 days. A large concourse of sympathetic neighbors attended the funeral preached by Rev. H.W. Hunt from Job 14.1.2.

Married on the 14th January 1841 by the Rev. H.W. Hunt Mr. Robert Axford of Hackettstown Warren County to Miss June Maria Wilson of Bethlehem Hunterdon County.

By the same on the 3rd of February Mr. William Drake of Bethlehem to Miss Mary daughter of Godfrey Case of Alexandria all of Hunterdon County New Jersey.

By the same on the 6th of February 1841 Mr. Johnson Hummer to Miss Unice Young both of Bethlehem Hunterdon County New Jersey.

Deaths

On the 28th of January 1841 Mr. Godfrey Case aged 74 years of Alexandria a worthy good citizan & member of the Presbyterian Church. The funeral sermon preached from Daniel 12th Chapter 2 and 3 verses.

On the 1st instant February 1841 Henry Rockafellar Esquire aged 94 years. He had been a ruling Elder in the Presbyterian Church of Alexandria more than forty years with good acceptance and great usefulness. He raised 12 children, had 77 grandchildren and 170 great grand children and 17 great, great grandchildren the whole number of descendants 276. The above statement was taken from one of his children collected and made with care about three years since; the number now is believed to be considerably larger.

Married by the Rev. H.W. Hunt Mr. Manuel Severs to Miss Mary daughter of Mr. Peter Young Senr the 20th February 1841 all of Bethlehem H. County.

Deaths

Another revolutionary pensioner gone. Master John Head of Bethlehem aged about 85 years (1841).

Mrs. Matilda A. Housel, wife of Asher S. Housel, the 6th March (1841) after a short illness in the 33rd year of her age. She has left to mourn her early loss a husband, two little daughters and aged parents & large family connections. Mrs. Housel possessed all those qualities to make a happy family, an excellent wife a tender mother, a lovely daughter, an affectionate sister – in the Bethlehem church but we believe our loss will be her eternal gain.

On the 15th March 1841 Mrs. Sarah Beavers aged about 80 years. Long may the Bethlehem church of which she was a worthy communicant remember she was a liberal suporter(sic); and her large family descendants her many lessons of instructions and prayers for their present and eternal happiness. The funeral services of the above were performed by their affectionate pastor, H.W. Hunt.

Farmer Honor Roll

Since the county's formation in 1714, it has been a rural agricultural community. The Holcombe-Jimison Farmstead Museum is dedicated to preserving Hunterdon's rural heritage and last year the Farmstead Museum inaugurated a *Farmer Honor Roll* on which the names of outstanding Hunterdon agriculturists can be inscribed.

Honored agriculturists will have demonstrated a dedicated interest in agriculture in our County and/or performed outstanding service to the rural community or made some important scientific or economic contributions in the field of agriculture.

WILLIAM J. LAUDERDALE

William J. Lauderdale [1886-1968] was in the first group of honorees. He was a West Amwell Township dairy farmer who was at the forefront of any community project or any move to improve agriculture.

He was the first child of Thomas and Alice [Macklin] Lauderdale and resided all his life in the house on Rock Road where he was born 26 November 1886. Bill and his brother Arthur, younger by two years, operated the family farm together after the death of their father until Arthur died in 1934. Therefore Bill and his hired men, dairyman Clifford Holcombe and poultryman Jobie Farlee operated it until Lauderdale's death. Rebecca Hart [1878-1956] married William Lauderdale in 1909. The couple had no children.

Agricultural Activities

Hubert Schmidt in preparing *Rural Hunterdon* relied on the valuable farm accounts kept by Thomas Lauderdale 1886-1898 and by his son William 1914-1940. These books were donated to the Hunterdon County Historical Society by Jobe Farlee in 1970.

Contesting The Will

On 28 March 1850, Barbara Martin, a middle-aged spinster, sent her nephew to find Dr. John Manners with a request that he come to the home which she shared with her sister, Susan; brother, William; his wife, Mary Ann (Maxwell); and their eight children. Barbara wasn't feeling well and she wanted to make her will. She needed the help of someone who could write and knew the proper legal terms and procedures.

Dr. Manners found her suffering from dropsy and consumption and immediately drew up the will as she dictated the terms to him.² As well as Dr. Manners, William Maxwell (William Martin's brother-in-law) and Benjamin J. Opdycke, a long-time neighbor, acted as witnesses. Before another 6 months had passed, Barbara was dead.

When the family heard the contents of the will, Barbara's brother, John, and her sister, Mary (Polly) Opdycke, a widow, were so dissatisfied with the will that they filed a caveat or protest against the will in an attempt to have the will declared invalid which would make their share of the

estate larger.3

Barbara's father, Lennard Martin, had made his will on 14 October 1843. It was proved 20 July 1844.4 He bequeathed to his daughters, Susan and Barbary, the farm on which he lived but excluding a meadow lot which was willed to son, William. The two sisters were also to receive all the household goods and furniture as well as half the livestock especially two cows. William received the other half of the livestock. The farm on which son, John Martin, lived was to be sold and the proceeds from the sale to be divided among Lennard's granddaughter, Mary (d/o William); grandaughter, Barbary Vliet; grandson, Lennard, (s/o John); and the testator's children, John, Susan, William, Barbary and Mary. The bond and mortgage which Lennard held against his son, Jacob, were cancelled. Weighing the bequests to each child, one can imagine that John and Mary felt unfairly treated by their father.

Seven years later, Barbara left a monetary bequest to her namesake and niece, Barbara, daughter of Jacob, who also received some money. Sister, Susan, gained ownership of Barbara's half of the "gilded looking glass," the corner cupboard, the copper tea kettle, the pewter, the cows and the chickens, all inherited from their father. Barbara bequeathed two good gowns to her niece Barbara, and 2 frocks to her niece, Mary, William's daughter. Sisters, Mary and Susan, were to take the residue of the clothing. No bequests were made to brother, John, whereas, brother, William was named executor and given the rest of the real and personal estate. Again, Mary and John were probably displeased with their portions. They set out to prove that their sister was mentally incompetent.

From 13 Dec. 1850 to early January 1851, the Judges of the Orphans Court, Samuel Hill, Robert Foster, Joseph Brown, and Jos. Thompson, heard testimony much of which clarified legal technicalities but some of which gives us a glimpse into the life of Barbara Martin.⁵

She had always lived with her father and continued to live in the same house after his death, always taking her meals with the family. Mary Martin, William's daughter, testified that her Aunt Barbara had taught all the children their ABC's, would knit, wash dishes, sweep the floor and help with most of the work around the house, although she "was no great hand to sew." Mary testimony continued. She said that Barbara churned, carried wood, hemmed towels and handkerchiefs, could cut her own "victuals" and do "most all the work that is necessary for women to do."

William Tharp, testifying for the executor, said that he'd worked for William Martin in 1848 and lived in the house during that time. Tharp said that Barbara "burned the coffee most part of the time" but helped take care of the children, helped wash the clothes, worked in the garden, picked weeks, fed the chickens and pigs, cut apples and dried them, knit – "nothing else, no work."

After consideration of all the testimony, the four Judges, ruled that Barbara had been mentally competent when she made her will which was finally entered for probate on 4 Jan. 1851.⁶ When she died, Barbara Martin left an estate worth \$611.39.⁷ It included 1 large looking glass, \$3.00; ½ eight-day clock, \$12.00; 1 cupboard and contents, \$6.50; "kitel and puter," \$2.50; poltry, \$3.50; two notes of hand with interest due, \$454.77.


