



The 101st Annual Meeting of the Hunterdon County Historical Society will be held Sunday March 29, 1987 at 2 p.m. in the Women's Club, Park Avenue, Flemington.

Steven Petrucelli will speak about New Jersey Tall Case Clocks. He is a collector and dealer who has owned over 1,000 clocks since he bought his first one at age twelve. Dr. Petrucelli will illustrate his talk with slides and possibly exhibit from his collection a clock made by Joakim Hill [1783-1869], one of the clockmakers from Hunterdon County.

Dr. Petrucelli owns The Adams-Brown Co., the oldest book publishing company dealing exclusively with books about clocks and watches. The Company was started by his grandfather over one hundred years ago and he is the third generation to operate the business. Society meetings are open to the public so invite a friend and join us on Sunday, March 29 for an interesting afternoon. Refreshments will be served following the meeting.

WITTWER MEMORIAL FUND

In his constant vigil to preserve original manuscripts Norman C. Wittwer introduced the use of microfilms into the Hunterdon County Historical Society library. He encouraged filming these documents so their contents were available for the patrons to use in their research, without endangering the documents themselves by repeated handling. He personally donated the funds to purchase the Society's first reader and films.

During his term as Librarian the microfilm collection was expanded by his continued efforts. As more records were available on films, more patrons utilized them. With increased use it became more important to provide patrons with copies of the information they found. However, without a reader-printer this is not possible.

The NORMAN C. WITTWER MEMORIAL FUND, established as a tribute to the man who had the foresight to encourage preservation of his County's heritage, will finance the purchase and operation of a microfilm reader-printer and additions to the film library.

RECORDS OF ABRAHAM WILLIAMSON, Paymaster 4th Regiment, Hunterdon County, New Jersey, Militia

(Continued from Volume 22, No. 3)

There are no records in the Williamson paymaster file covering May 1799 except for a paper headed "Name of Persons fined and in Joseph Boss' Warrant for May Training 1799." Eight names appear on this paper:

The names of these junior officers are listed on the company reports:

Holcomb, Emley (Ensign with Captain John Coryell, May and June 1804)

Reading, Thomas, Jr. (Ensign with Captain Jacob Johnson, May and June 1804)

Stryker, Abraham (Lieutenant with Captain Jonathan Higgins, June 1804)

Sutphin, James H. (Lieutenant with Captain Jacob Servis, June 1804)

Young, William (Ensign with Captain Jacob Servis, June 1804)

Twenty-five names are listed on the paymaster's report headed "Money yet due on Melitia Warrents uncollected" for the period 1797-1804. One of these names does not appear on the lists made by company commanders: Bagley, Anthony \$2 yet due on January 7, 1804. There is a notation that he served under Captain Jonathan Higgins.

The paymaster ledger entries begin: "DR THE 4TH REGIMENT OF HUNTERDON MILITIA 1797 Sept. 28 To cash pd. Major John Stevenson pr. order Collc. Bishop 1.2.6" (Pounds, shillings, pence, equivalent to \$3 at the time). Other entries are similar, and only a few give an explanation of the reason for the payment. The money paid out was from fines collected for nonattendance at militia training. Most of the payees are men whose names also appear on the reports of the company captains, but there are some additional names:

Militia Officers

Reading, Charles (Major) - Received payments from 1797 through 1800

Schanck/Schenck, Jacob (Major) - Received payments from 1799 through 1804

Stevenson, John (Major) - Received payments from 1797 through 1803

An entry of January 31, 1803, is more detailed:

"To cash paid Majors Stevenson and Schanck for Attending Court of Appeals 2 Monday in Novr. 1801 \$2" "To do. pd. Majors Stevenson and Schanck for Attending on a Settlement with Abm. Williamson \$2"

A dollar was the going rate for a day's work!

County Collectors

The law provided that fines collected by the paymaster should be turned over to the county collector. There were three county collectors during Abraham Williamson's term as paymaster.

Paul Kuhl on September 2, 1797, turned over to the paymaster the sum of £1.4.19s for militia fines due for the year 1796. The entry describes him as "Paul Kuhl late County Collector." In 1797 usage "late" meant "former."

David Bishop followed Paul Kuhl as collector, and his name appears on many of the paymaster records.

John Lequear followed David Bishop as county collector around August 14, 1804. He signed a receipt on August 12, 1805, acknowledging payment from "Abm. Williamson, late paymaster of the 4th Regt. of Hunterdon County, sundry clearances" in the total amount of \$24.90.

Physicians

Bown, John (Dr.) He received payments in the amount of 7/6, later \$1, during the years 1797 through 1803.

Prall, William (Dr.) He received payments in the amount of 7/6, later \$1, from 1799 to 1803.

(New Jersey laws governing the militia provided that a surgeon must pass on the age or disability of men who claimed exemption from militia duty.)

An entry in the ledger for August 14, 1804, reads: "Then settled accot. with Peter Fisher, Jsha. Van Cleave & Ralph Hunt they being a committee appointed by the freeholders of the County of Hunterdon to settle with the paymaster (agreeable to law) & there appeared to be a ballence due to the Regt. of \$147." This settlement was made on the occasion of the change in county collectors from David Bishop to John Lequear. The three men comprising the committee, according to New Jersey law, had to be over forty-five and of good repute.

The following men listed in the ledgers may be noncommissioned officers and men who paid their fines to captains or to the paymaster after their names had been entered on warrants. Their names did not appear on any of the company reports of absentees, but an examination of reports in the case of other men suggests this conclusion:

The CONTRA side of Abraham Williamson's ledgers shows fines paid for nonattendance at militia training. Most of these "delinquents" are listed above on the reports of their company captains, but there are some names which do not appear on those lists.

The initial entry on the first page of the CONTRA sheets illustrates the nature of the material:

"1797, May 15. By cash recd. of Capt. Jacob Schenck in full for his return of this date. 15 0"

Two of Captain Schenck's men had paid directly to him their fines for nonattendance at May training; Captain Schenck then paid the money he had received to the paymaster.

The following men whose names do not appear elsewhere paid fines as recorded on the CONTRA sheets. (The name of company commanders are not listed.)

The termination of Abraham Williamson's services as paymaster are reflected by two receipts in the Williamson papers preserved in the Special Collections and Archives, Rutgers University Libraries:

"Recd. this 6th October 1804 of Abraham Williamson ninety seven dollars being a ballance due from him as paymaster of the fourth Regiment of Hunterdon Militia agreable to a Settl. made by the Commissrs. appointed by the Freeholders, by an act of the Legislature.

"Recd. Augt. 12th 1805 of Abm. Williamson late paymaster of the 4th Regt. of Hunterdon Melitia, sundry clearances to the amount of nine dollers-likewise in cash fifteen dollers & ninety cents--

NEWSPAPER PROJECT

As a source of genealogical, historical and economic data, newspapers are unparalleled. The Hunterdon County Historical Society Library is fortunate enough to have among its collections a vast number of area newspapers, including the earliest ever published in the County.

Journalism of Hunterdon County began in 1825, when George Seymour issued the first copy of the *Hunterdon Gazette*. Since that time, an enormous number of newspapers have been printed in Hunterdon, and in virtually every area of the County. A large number of these publications are preserved in the Society Library. Unfortunately, with the passage of time, these newspapers, many large and ungainly in size, have deteriorated with age. Some have been put on microfilm, however, most continue to be bound in their original brittle bindings, and remain in a delicate state on the Library shelves.

Recently a corps of Society members, headed by Roxanne Carkhuff, removed some 75 bound volumes of the very earliest newspapers, placed them in acidfree encasements, relabeled them as to name, volume and years, and placed them in proper chronological order, according to title, on specially built steel shelving, designed to store the newspapers properly.

Every effort has been made to insure the proper handling of the newspapers, however, in the course of many years of being in the Society's possession, constant use and handling has caused some stray pieces of newspaper to become detached from their original issue. By great fortune, these loose pieces came to only four fragments.

Two of these, measuring roughly two inches square, name the newspaper from which they came, the *Hunterdon County Democrat*, however, the exact date was missing. The first of these noted that the *Hunterdon County Democrat* was "A Democratic Newspaper," and was "published every Tuesday morning, at Flemington, N.J., on [the] East side of Main Street, one door South of the Hunterdon County

National Bank." Robert J. Killgore was "Editor and Proprietor," and the "Terms of Subscription" came to "Two Dollars Per year in Advance." The reverse of the specifications of this newspaper carried an advertisement by G.C. Blaker, "Veterinary Surgeon," whose office was located at "Force's County Hotel, Flemington." The date of this ad gives the only clue as to the year of the newspaper: "March 2, 1886."

The second of the two smallest fragments indicates that the newspaper was also that of the Hunterdon County Democrat, though there is no evidence whatever as to date of the issue from which it came. Surviving are parts of the "Local Department," of which L.R. Runkle was "Local Editor." But three "local" notations are included on the segment piece: "Mr. Joseph Ricker has been appointed postmaster at Midvale;" "Delinquent taxpayers are now placed under the head of 'the elite directory'." and the Rev. Mr. Kline, of Summit," has taken over the "pastorate of the Clinton Baptist Church." The reverse of this piece details a Sheriff's sale concerning a tract of land in Lambertville, located on Washington Street. The date of the sale, "Monday, the Eighth day of March next" is the only clue given as to the date of the Democrat issue from which this shred came.

Of the two larger surviving fragments, neither indicates the name of the newspaper from which they came, nor the specific date it was issued. One carries an advertisement by Howard Sutphin, who apparently ran a department store, judging from the items he had for sale: "Rugs, Crockery, Trunks and Suit Cases." He also sold men's shirts "For every day and Sunday wear ... 50c. each." The time of the year in which this piece was issued was probably August, as a brief of the July weather was given. July, in this unknown year in Hunterdon County, proved to be quite warm and very dry. The highest temperature fell on 9 July, when it reached 98°. The mean for the month was 75.66°, and the total amount of rain, which fell on but two days in the month, came to a scant .22 inches. It was clear on 24 of the 31 days, and of the remaining 7 days, only one was cloudy throughout.

The largest fragment to become detached from its newspaper, measures roughly 5 inches by 6 inches. A series of "Notice of Settlement," concerning the estates of Jacob Todd, Peter G. Eick and Wm. R. Bearder, all bear date of 1 August 1910, indicating the release of this issue probably in that month and year. The only fully surviving advertisements broadcasted that the office of the Bank Building, Flemington, was offering "Local and Long Distance 'phones," and that Jacob Veit was selling "All Kinds of New Wagons."

Of special interest on this circa August 1910 scrap is the reverse showing the remaining portion of the Readington "local column," and the first few entries of the same column for Ringoes. Under "Readington" such pleasant brief newsy notes as "Daniel Cole has been treating his house to a coat of white paint, which has improved the looks of it very much," were passed along for all of Hunterdon to know. Also included were such notations as "Miss Anna Hall is spending some time with friends at Copper Hill," and "Ernest Wyckoff, of High Bridge, visited over Sunday with his parents, Rev. and Mrs. B.V.D. Wyckoff." Likewise, "Mr. and Mrs. John T. Schomp entertained the latter's parents, Mr. and Mrs. Chester Dilley," and "Mr. and Mrs. William E. Dow are entertaining the former's mother, of Long Branch." The Readington "locals" was closed with the news that "Eden Vail has been on the sick list for the past two weeks, but is very much improved at this time."

Under "Ringoes," in the same unidentified newspaper of circa August 1910, it noted that locally, "Mr. William Housel and family, of Trenton, have been spending the past week at the homes of their parents in town," and that "Mrs. John Dilts and family, of Sergeantsville, were calling on friends in town last Sunday."

These valuable fragments, as well as the vast numbers of back issues in the Society's collection, are available to the genealogist, historian and economist alike. We wish to extend our sincerest appreciation to Mrs. Carkhuff and her staff, which consisted of Mr. and Mrs. Theo D'Autrechy, George Kreutler, John Kuhl and Fred Sisser, III.

The Society is always anxious to increase its newspaper holdings, and would appreciate any Hunterdon County newspapers issued previous to 1925 which anyone would care to donate.
