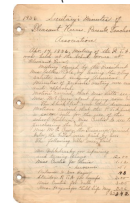

This small collection is comprised of the Minutes of the Pleasant Run School Parent-Teachers Association, 1936-1946. The Pleasant Run School was an elementary schoolhouse in Readington Township, NJ. The minutes are composed upon looseleaf paper removed from a small binder notebook. This collection would interest any researcher looking for information on Pleasant Run, Readington Township, NJ, and the families who resided there.
