1 Box. Estate papers of Clarence Pyatt, including news clippings, financial documents, correspondence, postcards, photographs, books, pamphlets, ephemera, ca, 1862-1946.

This collection includes two boxes of records relating to Clarence Pyatt and his family from Hunterdon County, New Jersey. The collection contains historical financial documents that belonged to ancestors on Mildred Pyatt's side of the family (the Case and Hart families), school materials from the Pyatt and Case families, genealogical information on the Pyatt and Case families, photographs, correspondance, and ephemera. The collection would interest anyone researching the Pyatt and Case families, the Hart and Case family business records, and school materials of the nineteenth century.

Context:

Name of Creator: Alexander Allen Pyatt

Administrative / Biographical history: Clarence Pyatt was born on May 2, 1892 in Flemington, New Jersey to Albert C. Pyatt and Henrietta Mount Pyatt. He was a local farmer and laborer who resided in the Raritan region of Hunterdon County his entire life. He passed away on January 31, 1977 in the Doylestown Hospital in Doylestown, Pennsylvania. His brother Alexander Allen Pyatt was born on September 5th, 1890. Alexander Pyatt worked as a farmer and, at one point, a truck driver and lived in the Flemington area for his whole life. He passed away on March 18, 1974 in Flemington, New Jersey. Alexander Pyatt married Mildred Viola Case in 1914. Mildred Case was born to Samuel Case and Mary Eliza Hart on April 2, 1892 in Raritan Township, New Jersey and died on November 11th, 1968 in Raritan Township. Alexander and Mildred's only son Allen was born on January 1st, 1918 in Flemington, New Jersey and died on June 29, 1999 in Flemington, New Jersey.

Custodial history: Many of the records in the two boxes originally belonged to Clarence Pyatt's brother, Alexander Allen Pyatt, and his wife, Mildred Viola Case Pyatt. At some point in time these documents came into the possession of Clarence Pyatt. He in turn gave the materials to Mary Elizabeth Sheppard, who donated the collection to the Historical Society.
