Scope & Content / Abstract:

5 Boxes. Records, minutes, ledgers, deeds, banking statements, certificates, correspondence, and ephemera of the Lackatong Lodge #114, c. 1854-1983.

This collection includes one box containing fifteen folders and 4 boxes containing fifteen ledgers in all relating to the Lackatong Lodge #114, I.O.O.F. of Hunterdon County, New Jersey. The collection chronicles more than a century of membership and prospective members, property deeds and banking transactions, constitution, by-laws, rules of order, and committee actions, lists including burial grounds of deceased members, and ephemera of this and other Odd Fellows Lodges of New Jersey.

Context:

Name of Creator: Jeff Quick

Administrative / Biographical history: The Lackatong Lodge #114 rented the assembly room in the upper story of the 1850 Quakertown stone academy building. Post 1915, when the academy building was torn down, Lackatong Lodge #114 occupied a two-story frame building on farmland located on Rt. 616 in Quakertown. The Lackatong Swimming Club was also located on the property. This collection would be of interest to researchers of Franklin Township, the Odd Fellows Fraternal organization, and family historians researching certain men of Quakertown and surrounding areas from the mid-19th to the mid-20th century.

Custodial history: Custodial history: Donated to the Franklin Archives by Jeff Quick, and then to the HCHS through Charles Mathews and Rural Awareness, Inc., in care of HCHS Trustee Lora Jones.
