Wurts' Law Office Historical Marker Dedication and Preservation Of Flemington's Greek Revival Heritage—Topics of June Meeting

A state historical marker at the Samuel Wurts Law Office Building near the County Court House will be dedicated at 2:30 P.M., Sunday, June 1.

The Hon. Wesley L. Lance of Glen Gardner, eminent Hunterdon County attorney, former County Judge and member of the State Legislature will dedicate the marker.

Following the dedication the Society's Spring Meeting will be held in the Court House.

Freeholder Kenneth V. Myers, our Society's long-time Treasurer, will speak on "Preservation of Our Architectural Heritage" and will trace the history of both the 1791 and 1828 court house buildings.


Mr. Myers will focus attention on the importance of preserving Flemington's handsome Greek-Revival architecture, the work chiefly of Mahlon Fisher, local master carpenter-builder-designer. Mrs. Frances Blomquist's research paper terms Fisher "A Provincial Ge-


ius."

In additions to the Wurts Law Office, Fisher's work includes his own home, the handsome Doric House owned by the Flemington Methodist Church; the Reading-Large House; the Dorf House; the former Merritt Company Building, 21 Mine Street. Mrs. Blomquist is inclined to attribute the 1828 Court House to Fisher but no documentation of this attribution has been found so far.

Architectural preservation is a timely subject in view of an Urban Renewal proposal which could radically alter Flemington's present distinctive architectural character.

Your Society Faces a Space Crisis

Your Society is making record progress in the acquisition of books, manuscripts and museum objects. The number of researchers using our resources grows by leaps and bounds. The space problem is acute!

Limited as we are to one room, without prospects of obtaining more space in our present location, it is inescapable that we shall be forced to store our museum material or to place it on loan to other institutions.

Library researchers are limited to 6 seats, yet we often have twice that number working at the same time.

Necessary preparation and cataloging work of our material is handicapped by lack of work space.

Thus far your Trustees have been unsuccessful in obtaining a building with more spacious quarters. Recent negotiations for the acquisition of a nearby historic house for that purpose have been unproductive so far.

A gift of furniture from the estate of a late member of our Society was given to another County institution as the heirs felt we were not in a position to accept it.

Mahlon Fisher:

Provincial Genius

Abstracts From a Paper by Frances Blomquist Read Before the Society

No one who passes through Flemington can fail to notice Main Street's five Greek Revival buildings. According to Hiram Deats, Fisher had been a common carpenter whose brother Jo was a cabinet maker. Mahlon built the Doric House for himself and the present Large House for a grandson of the colonial governor Reading. Later Fisher and Reading went into the lumber business together in Williamsport, Pa.

Deats added that the Wurts Law Office was built for Alexander Wurts. Fisher also built the house at 21 Mine Street, the former Meritt Company Office Building.

Fisher, the son of Joseph Fisher and Elizabeth Leonard, was born Feb. 8, 1810. He married Mary Ann Stires Jan. 30, 1834.

Recorded building agreements from the County Clerk's Office contain 5 references to Manlon Fisher as a contractor of buildings.

No. 24, Oct. 3, 1843, a frame house for Tur-

ins Sargeant.

No. 32, Nov. 14, 1845 a contract with William Clark for all masonry work for a house "Fisher is about to erect in Flemington." (THE DORIC HOUSE)

No. 41: an agreement to sell a house already built and owned by Fisher on Spring Street. (UNIDENTIFIED)


No. 43 1/2: Feb., 1847 an agreement to build a house for G. Evans in which reference is made to the Doric House "where (Fisher) now resides".

Fisher sold the Doric House in 1849 for \$3,-200.

Other buildings attributed to Fisher:

THE FLEMINGTON COURT HOUSE, dated 1828 (Mrs. Blomquist states "it is undoubtedly his earliest work in the neo-Greek syle.")

THE DORF HOUSE, 153 Main St. Erected c. 1845 for John G. Reading. (Recorded HABS No.

N.J.-731) Portico based on Stuart and Revett's "Antiquities of Athens)

THE ALEXANDER WURTS LAW OFFICE, 59 Main St. Mrs. Blomquist does not give date of construction but refers again to Stuart and Revett as inspiration for design.

THE FORMER MERRITT COMPANY OFFICE BUILDING, 21 Mine St. Once the home of Richard S. Kuhl, Flemington attorney. Mrs. Blomquist attributes the design to the Stuart and Revett drawing of the Temple on the Illysus called "Callirrhoe." She assigns no date of erection.

THE READING-LARGE HOUSE, 119 Main St. Referred to in Building Agreement 43-1/2 Dated Feb. 13, 1847 which states that the interior of G. Evan's house shall not be inferior to the finish of the 2nd story of said Reading's house. Built for James N. Reading c. 1847.

Flemington Hospitality:

The Women's Rest Room—An Historic Building

The Flemington Rest Room for Women and children with its beautiful front modelled after a Grecian Temple is a building of some historic interest.

It has accommodated three eminent New Jersey lawyers, two of whom reached nation-wide recognition. After them it was used as a office by five well known physicians, the last of whom was Dr. G.B. Tompkins.

Then the Farmer's Co-operative Association occupied it. Later it passed into the possession of the Woman's Club. They had felt the need of a Rest Room for our Borough but could not see their way clear to finance it.

The Retail Merchants' Association with the cooperation of the American Legion Fost 159, agreed to guarantee the rent and salary of a care-taker, under the direction of the Woman's Club.

The Club fitted up the building for its present purposes...the comfort and convenience of visitors to our Borough.

Samuel S. Southard, who built the little building, was born in Somerset County and graduated from the College of New Jersey, now Princeton University, at the age of 17. He spent 5 years as private tutor in a prominent Virginia family. He read law and was admitted to the bar in 1809. In 1812 he came to Flemington and while living in "Fleming Castle" built the house part of which is included in Miss Mary Killgore's residence, and the Rest Room next to it, for his law office.

Southard was president of the Board of Trustees of the Presbyterian Church. He helped organize the Hunterdon County Bible Society in 1816 and became its first president.

He represented Hunterdon in the Legislature in 1815. He moved to Trenton in 1817 which at that time was in Hunterdon County. He was County prosecuting attorney. In 1815 he was placed on the bench of the N.J. Supreme Court. In 1820 he was elected to the U.S. Senate. Later he was Attorney General and Governor of New Jersey.

Southard was Secretary of the Navy under both Monroe and John Quincy Adams. He was U.S. Senator for New Jersey from 1832 to his death in 1842. He was acting Vice President following General Harrison's death in 1841 when John Tyler became President.

Feter D. Vroom, a Columbia College graduate occupied this building from 1817 to 1819. From 1826 to 1829 he represented Hunterdon in the Legislature. He was then elected Governor and afterwards went to Congress in 1853-1857. He was U.S. representative at the Prussian Court in Berlin. He was one of the great lawyers of New Jersey and practised until his death in 1874 at the age of 82.

Alexander Wurts, a Princeton graduate, occupied this building 1820-1881. He was a member of the Assembly in 1822 and again in 1828 to 1832 when he was Speaker of the House. He was President of the Convention to revise the the State Constitution in 1844. He was then elected State Senator. In 1853 he declined an appointment to the State Supreme Court. In 1865 he was again elected State Senator. For many years he was Hunterdon County Judge.

Because of his undoubted integrity and his legal acquirements he was often consulted on legal questions of much importance.


THE PASSING OF A LANDMARK: A NEW ERA
