Hunterdon's Architectural

Heritage Topic

Of January Meeting


Hunterdon's diminishing heritage of historic and architecturally notable buildings documented by the Historic American Buildings Survey will be discussed by two noted architectural

historians at our January meeting.

John D. Milner of Philadelphia will discuss the work of Mahlon Fisher*.

In 1963 Mr. Milner was employed by the National Park Service to document Flemington's rich heritage of Greek Revival buildings.

Co-speaker, John Maas, is Visual Presentation Director of the City of Philadelphia, author of "The Gingerbread Age" (NY: Rineheart. 1957), an appreciative study of Victorian architecture.

Flemington's Hopewell house is described in Mr. Maas' book as "an Italian stone villa . . . translated into wood".

"Nineteenth Century Townscape" will be Mr. Maas' topic.

The importance of preservation of architecturally notable buildings which give a town its distinctive character will be stressed.

*Members of the Society will recall Mrs. Albert E. Bloomquist's delightful paper: "Mahlon Fisher, Flemington carpenter, a provincial genius" which was presented at one of our previous meetings.

1966 a Year of Progress

Your Society has made memorable progress this year:

Many new members have been added to our roll. The total is now 273.

Books, manuscripts and objects have been given to our collection; our Family Bible Collection continues to grow.

The \$1,000 Moreau Bequest was received as well as Mrs. George Robinson's gift of \$500 and, more recently, an anonymous gift of \$350. was made to establish a microfilm library.

Our first publications book list, issued in October, has already netted several hundred dollars which will be used to finance new publications of Hunterdon local history material. The success of this venture was assured by the generous gift of several hundred copies of books printed by Hiram E. Deats which were given to the Society by his son, Charles T. Deats, our Vice-President.

The third printing of Mott's "First Century of Hunterdon" (1878) is at the printers and will soon be in print at \$4.00. The second printing is sold out.

We have initiated the acquisition of a large post card collection of old Hunterdon views. We welcome additions.

A photocopying machine was given to the Society and shortly we expect to have our microfilm reader in use.

A 75 year backlog of binding of our valuable early county newspapers is under way. A backlog of rebinding of damaged books is also in progress.

The support of the membership which has made this progress possible is gratefully acknowledged!

Book Review

THE CALIFON STORY by Mrs. Helen Haggerty Geist, 1966. 8vo, 169p., 50 photos. \$3.00 available from the Hunterdon County Historical Society.

Many have wondered at the name "Califon". Some have even attempted to explain its origin without reference to (and perhaps without knowledge of) the earlier name, California, from which the present name was derived. Early in "The Califon Story" Mrs. Geist tells of one Jacob Neighbor, who fared well in the gold rush. and returned to his home and erected the mill and general store around which the village grew and prospered. The name "California" struck the fancy of the townspeople and was adopted in honor of their enterprising miller. For the reduction to its present, the reader may choose between two stories: one concerning two inebriated sign painters, the other about the railroad station signboard which was too short for the ten letters of the former name.

So the village was named Califon. "Interesting," you might say, "but trivial." What were the factors affecting its situation and development? Who were its people, and how did they keep pace with sociological and technological progress? More importantly, because of the broader application of such information, what were the details in the actual day-to-day life of the average townsman of the late nineteenth and early twentieth centuries?

Mrs. Geist handles all of these aspects of village life in an interesting and warmly readable manner, and, in so doing, makes of Califon a microcosm of rural America.


Forty odd years ago, Freeman Leigh prepared his "Notes on Fairmount." With the "Califon Story," we have a complementary work which gives fairly complete coverage to that region of northeastern Hunterdon. How fortunate we are to have had two who were able to remember and to collect their history and traditions put them into permanent form.


In closing, we wonder if, had it not been for Jacob Neighbor, Mrs. Geist's title would have been The Peggy's Puddle Story.

"Mahlon Fisher (1810-1874), Flemington carpenter, A PROVINCIAL GENIUS"*






THE DORIC HOUSE

Built for James N. Reading, c. 1847. Present owner: Edwin K. Large


"One of the most elaborate of the Greek Revival dwellings...by Fisher" (Historic American Buildings Survey No. NJ-396)

In 1854 a masonry vault was constructed in the basement and it served as the first home of the "Hunterdon Bank".

Erected in 1828, it is said to be Fisher's earliest work in the neo Greek style.

Owned and occupied by the Merritt Company.




THE ALEXANDER WURTS LAW OFFICE 59 Main Street

Owned by Hunterdon County.

Erected by Samuel S. Southard, in 1811: U.S. Senator, Governor of New Jersey and Secretary of the Navy.

Occupied 1817-1819 by Peter D. Vroom, later Governor of New Jersey. Also said to have been occupied by Nathaniel Saxton, noted Chancery reporter and author of Saxton's "Reports". Occupied by Alexander Wurts, 1820-1881. Occupied currently by County School Superintendent.



THE JOHN G. READING HOUSE 151-153 Main Street

Erected c. 1845 for John G. Reading. Present owner: Alfred A. Dorf.
