Scope & Content / Abstract:

Abstract: This is a collection of photographs from the Flemington area, ca. 1917-1935. It details aspects of life within the town as well as the scenery of different locations. This collection offers insights into Flemington, New Jersey, whether it is by examining the individuals or the events that surround the town in the early 1900s.

Scope and Content: Within this collection there are 22 photographs and a Newspaper drawing. The collection has mixed subjects contained in the images.

Photos 1 - 3 show cars and an individual along a dirt road in town.

Photos 4 - 8 show Flemington's Memorial Day Parade and the individuals that took part of event during the time.

Photo 9 shows a group of boys and another young man in the snow that covers Main Street

Photo 10 shows a groups of individuals inside a shop located in Downtown Flemington.

Photo 11 shows a young man, identified as Wilson Yard from the writing on the back of the photo. He is posed on a bicycle.

Photos 12 - 13 show the departure and the return of soldiers from World War I.

Photos 14 - 16 show the burning of the S.S. Morro Castle off the New Jersey Coast as well as the crowd that watched.

Photos 17 - 18 show the Newspaper drawing about the Lindberg Trial, as well as a photograph of the scene outside the Flemington Courthouse during that trial.

Photos 19 - 23 show storefronts and other buildings that were located in Downtown Flemington.
