**Scope & Content / Abstract:**

This collection of materials is from the Delaware Valley Horsemen's Association. It contains photographs from horse shows and gymkhanas; correspondence and receipts related to donations and sponsorships; purchases of medals and prizes for the shows; a sample medal; an honorary member certificate; a list of Association members in attendance at the first meeting; and one photograph from a parade.

This collection would be of interest to people who want information on previous prizes and classes in the DVHA shows, or names of members and sponsors of the association.

**Context:**

Administrative / Biographical history: The Delaware Valley Horsemen's Association is a nonprofit organization that was founded in 1949 by Welling C. Howell, VMD. Association members maintain the horse show grounds in Sergeantsville, New Jersey and staff the shows. The DVHA hosts shows for both amateurs and professionals across various equestrian disciplines and has the stated goal of promoting interest in horses and encouraging fairplay and good horsemanship in the use of all kinds of horses, with an emphasis on spreading these values to its younger members.
