Scope & Content / Abstract:

This collection contains photographs from the Howard Stintsman estate. There are multiple people in the various photographs with Howard and Lester being identified. Many photos are of the same group of people at different places. This collection also includes clipping from various newspapers that are relevant to the Stintsman family, including photographs that were printed in the newspapers in the 1970s and 1980s, some of which were originally captured decades earlier. The newpaper photographs include photos of people at dance lessons, a photo of Howard Stintsman in a golf tournament, a photo from a Frenchtown Presbyterian Church Banquet, and a photograph of a boat. There is also one record of a memorial service for Garfield Stintsman, and a postcard and Christmas/New Years card from 1924. The photographs date from ca. 1900 to 1988.

This collection is of interest to those looking for photographs of the Stintsman family, or photographs in general from this date range, as well as those looking for newspaper clippings from the 1970s-1980s.
