Description Abstract: This collection contains publishers' circulation data and audit reports validating that data for the Hunterdon County Democrat (Flemington, 1938-1992) and the Delaware Valley News (Frenchtown NJ, 1950-1994). The collection also includes two account ledgers (1945-1962) that contain accounts from the Hunterdon County Democrat and Delaware Valley News and two membership certificates from the Associated Press, one for D.H. Moreau (1948) and one for H. Seeley Thomas, Jr. (1964).

Scope and Content: The circulation audit reports reflect the confirmation by the Audit Bureau of Circulations of average paid circulation statistics reported by the newspaper publisher. Complete audit reports are included, as well as publishers' submission of circulation data to the bureau. The ledgers contain financial information related to the operation of the Hunterdon County Democrat and Delaware Valley News, including amounts paid to/withdrawn by D. Howard Moreau, sole owner and publisher of the Democrat from 1933-1963. This collection would be of use to those interested in mid-20th-century newspaper publishing, as well as population shifts and newspaper readership in Hunterdon County in the 20th century.
