**Description** Abstract:

The collection primarily consists of papers of the Samuel Case family, over 800 photographs, and papers of Mary Elizabeth Sheppard 's genealogical and historical research. The collection would be of interest to genealogists, those interested in Hunterdon County farm life in the early 20th century, Raritan Township and East Amwell Township.

The Case family lived on a farm located on Route 12 in Raritan Township, currently the site of the Hunterdon County complex. The papers consist mainly of personal and business correspondence, receipts, insurance policies, and real property information. In addition, the collection contains records of the Tunis Case Family Reunion, which has been held on and off for over 100 years.

The collection contains over 800 photographs relating to the Case, Hutchinson (Mary Elizabeth's mother), and Sheppard families. In addition to photographs of family members, the photographs pertaining to the Case and Sheppard families depict many aspects of Hunterdon County farm life during the early 20th century.

Mary Elizabeth Sheppard's genealogical materials consist of her research into the Case, Hutchinson and Sheppard families, including family trees of the Case and Sheppard families and 3 volumes of the Case genealogy.
