Description Collection consists of 21 Folders of photographs, manuscript items and ephemera related to the Kitchin family and the Hunterdon County area in general. The majority of the collection is ephemera of Hunterdon County history with material from 1869 to 2007.

The primary focus of this collection appears to be a general appreciation of Hunterdon County history and culture. There is a focus on the Kitchin family specifically in the form of photographs of multiple family members, as well as a marriage certificate and bridal book from Harold Kitchin's wedding.
