Description

This collection consists of studies of the architectural and historical significance of numerous buildings and districts conducted by Dennis Bertland Associates. The greatest number of studies resulted in preparation of a nomination to the National Register of Historic Sites. Others were done to guide a grant for a restoration project or simply to document the site for the owner 's use. A typical site file contains copies of a large number of deeds, census records, wills, newspaper clippings, published histories, etc. For the researcher, there is a vast amount of such information beyond that which is included in the National Register nomination or other formal documentation of the site. The collection should be of great interest to individuals seeking information on their historic home or district.

Arrangement is in alphabetical order by site name (except for the last two sites which were identified after the other sites had been numbered). Folder numbers consist of the site name number followed by a decimal point and then the folder number within that site. Thus folders for site 1, the Amsterdam Historic District are numbered 1.01, 1.02, and 1.03. If there is a written report for the site, it is the first folder within that group, and any photographs are in the second. Beyond that the group folders have no designated contents, and it is believed that anyone interested is a particular site would want to examine the folder contents for the entire site.

Most researchers will probably know the location of the target site rather than the exact name, and for that reason an index has been compiled, listing by county, then by municipality, and finally by the assigned site name.
