Description Abstract: The collection is comprised of New Jersey State Historical Site Evaluation Worksheets. Fifty-One sites have been evaluated, and each includes the worksheet, a map and commentary. Photographs have been provided for many of the sites, as have the related negatives. All the sites are located in Hunterdon County.

Scope and Content:

The Hunterdon County New Jersey Historic Site Survey Collection consists of 57 folders, the first containing the index, and number 43 containing extra worksheets. Every other folder contains a worksheet; most folders also contain photographs and the matching negatives. Commentaries have been created for each site documenting its history, information about the building, and when appropriate, the history and documentation of the people and the historical significance of the area. The commentaries note works cited, references, and individual correspondence about the site as well as ancillary information.

Folders may contain from four to thirty items. The majority of the documents are typewritten with handwritten notations. The surveys were conducted over a period of two years, beginning in 1960 and ending in 1961.

Dr. Johnson has provided an index that divides the sites by category. There are twenty-three categories, fourteen of which were represented in the original collection. Addition of material from Accession 2015.053 completed the missing categories in the original collection and all categories on the index are now included.

There is a six-page index of categories. Each category is determined by the Check List, and referenced to the appropriate number. For example, "Architecture" is the second listed, as (2), and is referenced as #3, according to the Check List. Each category lists the number, name, location and a short description of each site that was evaluated. There are 17 Categories listed and each contains from (1) to (6) sites. Category #1 Archeology, Category #8 Indians, and sites 2 and 3 from Category #17 Medicine, have handwritten notes, dated May 18, 1975, that will be sent later. Addition of material from Accession 2015.053 completed the missing categories in the original collection, and all categories on the index are now included.

Accession 2015.053 also included some photographs and negatives unrelated to the categories in the Evaluation; these have been included in folders 54 to 57.

Dates of Creation		Administrative Biographical History	Edward Johnson, PhD. (English) was a member of the Hunterdon County Historical Society. From 1960-61, he was the Chairman of the Hunterdon County Committee on Historic Sites and Structures, and conducted this survey as a private endeavor paid for by D. Howard Moreau, solely for the good of the county. Dr. Johnson established his own criteria for selecting the sites. This helps to explain the absence of several prominent historical structures. Johnson's survey was used circa 1975 as a source the formal, state-funded historical survey conducted by the Hunterdon County Historical Society. Johnson conducted these surveys with the assistance of several researchers and photographers. Many of the photographs were taken by Michael Ciavolino of Clinton, NJ who was assisted by Doug Martin.
